Limited Liability Partnership (LLP) is a format that combines the flexibility of partnership and the advantages of limited liability of a limited liability company at a low compliance cost. Post changes to FDI regulations in November 2015, 100% FDI in LLP is now permitted under the automatic route.

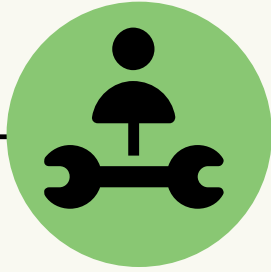

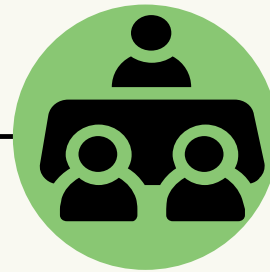

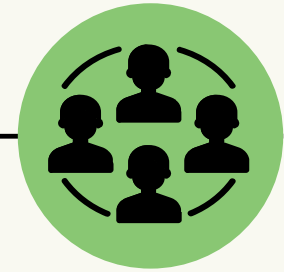
